President's Message

HAPPY NEW YEAR!

THOUGHTS AND PRAYERS are needed again. As of this writing, many of our friends and family members are suffering through terrible, massive wildfires burning out of control in southern California. Coping with the aftermath will be worse than the fires.

ANNUAL ASSESSMENTS have increased for 2018. It may be a good idea to be prepared for annual HOA increases for the foreseeable future. Being prepared and budgeting for this will ease the "pain" come each January. We are one of the most financially sound retirement areas in the Portland metropolitan area including many senior HOA communities to the north and south of us. This is largely due to our very healthy reserve account which is the result of our SCA Board's willingness to be "unpopular" when the budget comes out, as well as the efforts of our staff and Committees to be prudent with our funds. Look at it this way, the reserve account is like your own savings account. You hope for the best but plan for the worst. The car that was supposed to last another year doesn't, the washer and dryer go out at the same time, and the roof springs a leak. If you are prepared, you don't have to take out a loan because you have been putting away funds for this kind of emergency. Same idea for an HOA reserve account. After the bills are paid, the rest goes into the reserve account (savings account) which in turn enables us to cope with unexpected expenses or repairs and to anticipate major expenses as our facilities and amenities continue to age....like our Clubhouse, swimming pool, pickleball/tennis courts, parking lot, maintenance shop, etc. The last thing we want is to be in a special assessment situation where we would have to come up with a large sum of money per household in order to address an unexpected expense which we couldn't pay for out of reserve account because there wasn't enough money. Not a lot of fun to write about this, but being prepared will help us in the long run to maintain our beautiful home....Summerfield.

THANK YOU to all of the Committee and Club Chairs, Co-Chairs and Presidents and members for a wonderful year. Your dedication to your Committees and Clubs is impressive and so much appreciated!

And on that note, VOLUNTEERS.....are very much needed. Let's change the 20/80 rule (20% of the people do 80% of the work) this year to at least a 30/70.

RING in 2018 and make it your best year ever.

SCA Board Meeting Report

This report is a recap of the meeting. For details, see the minutes on the Clubhouse bulletin board.

December 11, 2017 Board Meeting

Present: Nash, Miller, Strain, McCall, Gray, Nottingham, Parkinson, Cook, C. Lindsey. **Absent:** Estates. Meeting called to order at 9:00 AM. Minutes approved from November 2017 Board Meeting.

Visitors: Resident Donovan Madden spoke on behalf of the Disaster Planning Committee, provided update on recent First Aid classes, planning another show-n-tell event in March.

Golf Course Report – Sullivan: Course conditions are good overall, leaves are down, sweet gum is a mess, able to get the rough mowed, now getting frozen and going to temporary greens; drainage work on #2 and #3 has helped. Since purchasing new lasers for goose control, the geese have not been around on #5 as much, more on #9, so Pro Shop is using their laser frequently. New spray rig ordered, but will not be delivered until vendor has a full truck. Working with shipping container vendor on access and delivery. Received Clean Water Services invoice for irrigation water for the year, used 22.5 million gallons, invoice was \$24K, lower than expected. Based on their estimated increase for next year, 2018 invoice should be around \$32K for same usage, then subsequent years should follow Tualatin Valley water rate increases. In comparison, another local course spent \$132K on irrigation water and if we needed to use City of Tigard water, it would be in excess of \$88K.

Golf Pro Shop Report – R. Lindsey: Geese and widgeon issues near #9 and Pro Shop and unfortunately, lasers don't work well in the bright sunlight that we've had lately (which is unusual). For November, there were 19 rain days, fell short of budget by about \$1,400. Noted that it's been one of the worst golf years in the northwest, starting with the rains in October 2016, then heavy snow/ice,

back to rain, then the summer fires and air quality issues. Concerned about decreases in resident play, from annual passes, to punch cards to daily green fees. Open to ideas on how to capture resident play, and if not, then how to maximize public play. Discussion again on tournament play.

New business:

A. **Golf Course Rules Update F 6.21:** Discussion on tee times for all passholders. Motion made, seconded and approved to update the Golf Course Rules, F6.21.

B. **Holiday Light Tour Request:** Request to permit carts/walkers on the golf paths at night to view holiday lights. Discussion on safety concerns and lighting concerns. There are organizations that rent/set-up light displays and provide transportation around to view and if there is a group that would like to investigate and create a proposal next year in advance, that would be welcome. Motion made, seconded and approved to deny request.

Treasurer's Report – Nottingham: Total November Operating Income of \$23,279.34; Total November Operating Expenditures of \$62,764.49; Cash on hand as of 11/30/17 of \$235,819.36. Total November Reserves Income of \$14,069.24; Total November Reserves Expenditures of \$0. General Reserve Balance as of 11/30/17: \$782,481.17. New Buyers Fee income for November was \$14,000. New Buyers Fee account balance as of 11/30/17: \$308,436.32. Total General Reserves plus New Buyers Fee account: \$1,090,917.49. Check registers reviewed for November. Motion made, seconded and approved to accept the entire Treasurer's report. Miller stated that real estate market is busier than it should be; Cook added that there is a buildup of inventory

right now. Nottingham provided percentages compared to budget year-to-date. Discussion on continued budget town hall meetings in the spring to share information with residents again.

Correspondence – C. Lindsey: Correspondence related to sub-association hierarchy and compliance, street trees, sidewalks, yard ornamentation, differences between a Committee/Club/Activity, the art show, CC&R language and voting procedure, budget explanations.

Unfinished Business – None

Administrator's Report – C. Lindsey: Continued work on the CC&R Amendment, 2018 budget, assessment collection preparations, benefits administration and an OWCAM meeting regarding reserves and advance rules enforcement.

City of Tigard Liaison Report – Van Vlack: Considering another City Council Town Hall hosted here in early 2018; discussion on format and topics might include light rail and the potential bond/levy.

New Business:

C. Fitness Club Name Change Approval: Motion made, seconded and approved to approve the updated name change from Fitness Club to Wellness and Fitness Club.

D. Golf Tag Refund Request: Motion made, seconded and approved to table request until January Board Meeting. Will review all requests since the change in the policy for comparison.

E. Occupancy Variance Extension Request: Motion made, seconded and approved to deny extension request; giving 60-day notice to vacate by February 28, 2018.

F. 2018 Budget Final Approval: Motion made, seconded and approved to approve final 2018 budget.

McCall – Liaison to Clubhouse, Newcomers & Neighborhood Watch: For Clubhouse Committee, motion made, seconded and approved to dissolve the Policy F6.12 Kitchen Check-Off List, as it will be more of an internal document and be updated regularly.

Strain – Liaison to Swimming Pool, Volunteer Appreciation, Sub-Associations: Nothing to report.

Nottingham– Liaison to Architectural/ Landscape & Pro Shop: Nothing to report.

Miller – Liaison to Clubs/Activities, Library, Website, Greens: Website team meeting at the end of this month.

Gray - Liaison to Courts, Common Area Landscape, and Disaster Planning: Pickleball group using old nets during winter, saving new ones for spring.

Parkinson – Liaison to Apartments: Occupancy at 98.97%; just a couple available to rent, experiencing some underground exterior wiring issues, since it is original wiring.

In my estimations for the 2017 year, we should have a \$100-\$112K additional transfer in 2018 (this is done after the audit). This is the traditional amount we've seen for years as the 'left over' amount in the operating budget. We are required to transfer it to reserves. This is generally created from the \$50K Miscellaneous Contingency and a mix of the other line items. Yes, there is a cushion in the operating budget each year, but there has to be. When we are creating the budget in September and October, we are not aware of the proposed increases in UTILITIES. We do not know the rate changes for the BENEFITS or which employees will accept or decline benefits. Certain CONTRACTS have not been finalized (such as landscaping, janitorial, aeration, etc.). Who knows what the price of FUEL will be? How many INSURANCE DEDUCTIBLES will we have? Budgeting for an association is very different than budgeting for a corporation. If the budget is too tight, either on expenses or revenues or both, then there is a risk of not having enough money in the operating bank accounts to operate at the end of the year. Having a little extra cushion does nothing to harm the association, as everything 'left over' gets transferred to the reserves. We are not a corporation where extra profit goes to the owner or the officers or to bonuses---it goes to reserves!

For 2018 Operating Budget, here are some notes: Civic Assessments up \$57,991 compared to 2017 Actual/Forecast, a 6.2% increase. Golf Income down \$4,742 compared to 2017 Actual/Forecast, a 1.56% decrease. Total Income up \$52,688.83, 4.24% (note did not include miscellaneous income or interest income)

Administrative Expenses up \$95,244 compared to 2017 Actual/Forecast, a 26% increase. This is due to budget line items of \$10K for insurance deductible, \$10K for brick wall, \$13K increase to common area landscaping for oak tree pruning, \$5K for the CC&R vote, \$5K in pool, \$4K to other committees and a blend of other line items.

Golf Expenses up \$38,587 compared to 2017 Actual/Forecast, a 7.0% increase. This is actually quite nominal and might be too tight, considering we don't know what to expect weather wise and that greatly affects our irrigation water usage. And as mentioned on page 4, what will the fuel rates be, what is the price of fertilizer, sand/rock and contracts for aeration, etc.?
